



Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is reported to be extremely contagious. The state of medical knowledge is evolving, but the virus is believed to spread from person-to-person contact and/or by contact with contaminated surfaces and objects, and even possibly in the air. People reportedly can be infected and show no symptoms and therefore spread the disease. The exact methods of spread and contraction are illness, personal injury, permanent disability, and death.

The Greensboro Children's Museum cannot prevent you [or your child(ren)] from becoming exposed to, contracting, or spreading COVID-19 while utilizing **Greensboro Children's Museum's** services or premises. It is not possible to entirely prevent against the presence of the disease. Therefore, if you choose to utilize Greensboro Children's Museum's services and/or enter onto Greensboro Children's Museum's premises you may be exposing yourself to and/or increasing your risk of contracting or spreading COVID-19. The Greensboro Children's Museum in no way warrants that COVID-19 infection will not occur through participation in activities or accessing the Greensboro Children's Museum.

GUEST AGREEMENT: I hereby agree, represent, and warrant that neither I nor my children shall visit or utilize the Greensboro Children's Museum, services, and programs of the Greensboro Children's Museum (other than any exclusively online services and programs) within 14 days after (i) returning from highly impacted areas subject to a CDC Level 3 Travel Health Notice, (ii) exposure to any person returning from areas subject to a CDC Level 3 Travel Health Notice, or (iii) exposure to any person who has a suspected or confirmed case of COVID-19. The CDC Travel Health Network is continuously updating this list and I agree that I am aware of this list and the countries listed.

I agree to check the CDC Travel Health Notices list prior to utilizing the services and programs of the Greensboro Children's Museum, on a daily basis if necessary. I hereby agree, represent, and warrant that neither I nor such participating children shall visit or utilize the Greensboro Children's Museum's services, and programs if he or she (i) experiences symptoms of COVID-19, including, without limitation, fever, cough or shortness of breath, or (ii) has a suspected or diagnosed/confirmed case of COVID-19. I agree to notify the Greensboro Children's Museum immediately if I believe that any of the foregoing access/use restrictions may apply

ASSUMPTION OF RISK: I have read and understood the above warning concerning COVID-19. I acknowledge and assume both the known and potential dangers of utilizing the facilities, services, and programs of the Greensboro Children's Museum and acknowledge that my use thereof (or the use by my participating children) may, despite the Greensboro Children's Museum's reasonable efforts to mitigate such dangers, result in exposure to COVID-19, which could result in quarantine requirements, serious illness, disability, and/or death.

WAIVER OF LAWSUIT/LIABILITY: I hereby forever release and waive my right to bring suit against **Greensboro Children's Museum** and its owners, officers, directors, managers, officials, trustees, agents, employees, or other representatives in connection with exposure, infection, and/or spread of COVID-19 related to utilizing **Greensboro Children's Museum's** services and premises. I understand that this waiver means I give up my right to bring any claims including for personal injuries, death, disease or property losses, or any other loss, including but not limited to claims of negligence and give up any claim I may have to seek damages, whether known or unknown, foreseen or unforeseen.

CHOICE OF LAW: I understand and agree that the law of the State of North Carolina will apply to this release.

BY PURCHASING ADMISSIONS TO THE GREENSBORO CHILDREN'S MUSEUM, I AGREE THAT I HAVE CAREFULLY READ AND FULLY UNDERSTAND ALL PROVISIONS OF THIS RELEASE, AND FREELY AND KNOWINGLY ASSUME THE RISK AND WAIVE MY RIGHTS CONCERNING LIABILITY AS DESCRIBED ABOVE.
